## HOUSE BILL No. 1177

DIGEST OF HB 1177 (Updated February 15, 2021 2:12 pm - DI 77)

Citations Affected: IC 12-9.1.

**Synopsis:** Strategic plan on dementia. Requires the division of aging (division) to develop a strategic plan concerning dementia in Indiana. Requires the division to submit an annual report to the general assembly concerning the dementia strategic plan and the outcomes of implementing the dementia strategic plan.

Effective: July 1, 2021.

# HOUSE BILL No. 1177

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 12-9.1-5 IS ADDED TO THE INDIANA CODE
2	AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3	JULY 1, 2021]:
4	Chapter 5. Strategic Plan to Address Dementia
5	Sec. 1. The division shall develop a dementia strategic plan to
6	identify and significantly reduce the prevalence of dementia in
7	Indiana.
8	Sec. 2. (a) The dementia strategic plan must include the
9	following:
10	(1) Proposed state actions.
11	(2) Implementation steps.
12	(3) Recommendations to carry out the purposes of the plan.
13	(b) The dementia strategic plan must do the following:
14	(1) Assess Indiana's current and future status concerning
15	dementia, including the following:
16	(A) Determine Indiana trends concerning the diagnosis of
17	dementia, and the current and future economic cost on



1	Indiana.
2	(B) Evaluate the services, resources, and care available to
3	address the needs of individuals with dementia, and their
4	families and caregivers.
5	(C) Identify methods to reduce the financial costs of
6	dementia care while improving care and services in
7	Indiana.
8	(2) Identify strategies to increase awareness of dementia,
9	including the following:
10	(A) Educate health care providers:
11	(i) on the importance of early detection and diagnosis of
12	Alzheimer's disease and dementia;
13	(ii) on the importance of an annual wellness visit for
14	cognitive health; and
15	(iii) of Medicare having a billing code for individuals
16	with cognitive impairment.
17	(B) Promote culturally appropriate public health
18	campaigns to increase understanding and awareness of
19	early warning symptoms of dementia, and the value of
20	early detection and diagnosis.
21	(C) Incorporate messages on brain health, including how
22	to reduce the risk of cognitive decline, in existing public
23	health campaigns and in diverse community settings where
24	there is a greater risk of developing dementia.
25	(3) Identify strategies to enhance Indiana's dementia based
26	workforce, including the following:
27	(A) Analyze dementia specific training requirements for
28	paid professionals engaged in the care of individuals with
29	dementia in institutions and home and community based
30	settings.
31	(B) Increase the number of individuals pursuing careers in
32	dementia care and geriatric occupations to meet future
33	state needs.
34	(C) Enhance the capacity of adult protective services
35	workers and law enforcement to properly respond to
36	individuals with dementia.
37	(4) Identify strategies to increase access to home and
38	community based services for individuals with dementia,
39	including the following:
40	(A) Identify the type, cost, and variety of dementia services
41	in Indiana.
42	(B) Assess capacity and access to adult day care, respite



1	care, assisted living, and long term care services.
2	(C) Identify methods to expand Indiana's health care
$\frac{2}{3}$	system capacity to meet the growing number and needs of
4	individuals with Alzheimer's disease and dementia.
5	
6	(5) Identify strategies to enhance the quality of care for
7	individuals with dementia, including the following:
8	(A) Assess quality care measures for long term care
8 9	facilities, assisted living facilities, and residential programs
-	available to care for individuals with dementia.
10	(B) Uncover any existing gaps in dementia services and
11	determine a plan to cover the gap in service.
12	(C) Identify methods to improve dementia services
13	provided in home and community based settings.
14	(6) Recommend strategies to decrease health disparities
15	concerning dementia in ethnic and racial populations in
16	Indiana.
17	(7) Identify and increase state based support for Alzheimer's
18	disease research through Indiana universities and other
19	resources.
20	(8) Identify needed state policies or actions to act upon
21	findings under this section and implement the
22	recommendations of the plan, setting forth a time frame for
23	implementation.
24	Sec. 3. (a) Beginning December 1, 2021, the division shall submit
25	annually:
26	(1) a summary of the dementia strategic plan; and
27	(2) a report concerning outcomes from implementation of the
28	dementia strategic plan;
29	to the general assembly.
30	(b) The dementia strategic plan and report required under
31	subsection (a) must be submitted in an electronic format under
32	IC 5-14-6.

Delete the title and insert the following:

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Page 1, delete lines 1 through 6.

Page 1, line 7, delete "IC 16-46-17" and insert "IC 12-9.1-5".

Page 1, line 10, delete "17." and insert "5.".

Page 1, line 11, delete "state department" and insert "division".

Page 3, delete lines 30 through 42, begin a new paragraph and insert:

"Sec. 3. (a) Beginning December 1, 2021, the division shall submit annually:

(1) a summary of the dementia strategic plan; and

(2) a report concerning outcomes from implementation of the dementia strategic plan;

to the general assembly.

(b) The dementia strategic plan and report required under subsection (a) must be submitted in an electronic format under IC 5-14-6.".

Delete pages 4 through 5.

Renumber all SECTIONS consecutively.
