A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

- 28 tempore of the senate to represent the senate. Three (3) of the
- 29 members appointed under this subdivision shall serve on the
- 30 standing fiscal subcommittee created under section 8(b) of this
- 31 chapter.
- 32 (4) Six (6) members shall be appointed by the speaker of the
- 33 house of representatives to represent the house of representatives.
- 34 Three (3) of the members appointed under this subdivision shall
- 35 serve on the standing fiscal subcommittee created under section
- 36 8(b) of this chapter.
- 37 (b) Notwithstanding subsection (a)(3), after consultation with the
- 38 minority leader of the senate, the president pro tempore of the senate
- 39 shall appoint three (3) of the members from the minority party of the
- 40 senate.
- 41 (c) Notwithstanding subsection (a)(4), after consultation with the
- 42 minority leader of the house of representatives, the speaker of the



1 house shall appoint three (3) of the members from the minority party
2 of the house.
