HOUSE BILL No. 1352

DIGEST OF HB 1352 (Updated January 24, 2023 9:31 am - DI 140)

Citations Affected: IC 12-15.

Synopsis: Telehealth services. Provides that the office of Medicaid policy and planning may not require: (1) a provider that is licensed, certified, registered, or authorized with the appropriate state agency or board and exclusively offers telehealth services to maintain a physical address or site in Indiana to be eligible for enrollment as a Medicaid provider; or (2) a telehealth provider group with providers that are licensed, certified, registered, or authorized with the appropriate state agency or board to have an in-state service address to be eligible to enroll as a Medicaid vendor or Medicaid provider group.

Effective: July 1, 2023.

HOUSE BILL No. 1352

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 12-15-11-10 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2023]: **Sec. 10. The office may not require the**
4 **following:**

5 (1) A provider that is licensed, certified, registered, or
6 authorized with the appropriate state agency or board and
7 exclusively offers telehealth services (as defined in
8 IC 12-15-5-11(a)) to maintain a physical address or site in
9 Indiana to be eligible for enrollment as a Medicaid provider.

10 (2) A telehealth provider group with providers that are
11 licensed, certified, registered, or authorized with the
12 appropriate state agency or board to have an in-state service
13 address to be eligible to enroll as a Medicaid vendor or
14 Medicaid provider group.
